## **COVID – 19 Holiday Camps; Additional Measures**

Symptoms of Covid -19;

- If your child is displaying symptoms of Covid-19 please do not attend for 7 days from the day they started showing symptoms, you will be issued a full refund for days not used.
- If your any member of your child's household is displaying symptoms of Covid-19 please do not attend for 14 days from the day they started showing symptoms, you will be issued a full refund for days not used.
- If your child displays symptoms of Covid-19 whilst attending our camps, they will be placed a quarantine room, with a member of staff wearing PPE. You will be called and asked to collect your child as soon as possible. You will be required to inform us if your child tests positive for Covid 19.
- If your child is in a bubble with a child who is displaying symptoms, you will be informed.
- Children and staff attending our holiday camp are expected to get themselves tested if they show symptoms. If they test positive, the adults and children within the bubble will need to self-isolate for 14 days

## Staff;

- Tested Weekly using lateral flow test kits
- Temperature checked on arrival
- Hand sanitiser on arrival
- Hand sanitiser given to all staff
- 2m social distancing
- Wear face-mask when indoors
- PPE available

## Sign in;

- Each bubble will have their own entrance and exit
- one-way system
- 2m waiting lines for pick up/drop off
- No parents to enter the venue
- Parents & Guardians to wear face-masks
- Hand sanitiser for children on arrival

## Groups of Children;

- No more than 15 children in a group with same 2-3 adults supervising all day
- Bubbles not to mix throughout the day
- Bubbles split into schools as best as we can
- Encourage parents/guardians to book same bubble for each booking.
- Where it is not possible to group children in the same bubble as they are in during the school day – for example, if you only have one or two children attending your provision from the same school day bubble, you may need to group them with other children from outside their school day bubble.

- Where it is not possible to group

# children in the same bubble as they are in during the school day, you should try to keep them in small groups of no more than 15 children and at least one staff member, with the same children each time they attend, as far as possible. You should also ensure any children from the same school are kept together. You should only group children from different schools together where it is necessary.

- Where it is not possible to follow school day bubbles, you should also work with parents and carers to try and keep siblings together. This will help minimise the amount of mixing between different households and contacts.
- Frequently review these groups to minimise the amount of 'mixing'. For example, when new children register for your provision, you should determine whether they attend the same school or early years setting as other children in your setting and group them together if appropriate.

## Attendees;

As set out in the <u>COVID-19 Response – Spring 2021 guidance</u>, from 29 March, and in line with when schools close for the Easter holidays, out-of-school settings and wraparound providers will be able to offer:

- outdoor provision to all children, without restrictions on the purpose for which they may attend
- indoor provision to:
  - vulnerable children and young people
  - children on free school meals, where they are attending as part of the Department for Education's holiday activities and food programme
- other children, where the provision is:
  - reasonably necessary to enable their parents and carers to work, search for work, undertake education or training, or attend a medical appointment or address a medical need, or attend a support group
  - being used by electively home educating parents as part of their arrangements for their child to receive a suitable full-time education
  - being used as part of their efforts to obtain a regulated qualification, meet the entry requirements for an education institution, or to undertake exams and assessments

## Activities;

- The children will still enjoy a day full of fun activities with additional social measures
- All activities will be COVID 19 risk assessed
- Pens & pencils packs will be given to children if requested cleaned at the end of each day
- Play equipment to be limited to bubbles and wiped down before and after play
- Encourage 2m distancing **but we cannot promise that children will be always 2m apart**, indoors or outside.
- Sport camps will be assigned equipment at the start of the day eg football 1 = Billy
- Children will not be able to mix with friends from bubbles throughout the day.
- Only equipment that can be easily cleaned will be used.
- Toileting will adhere to a one in one out system.

Play times;



- Each bubble will be assigned an area to play in and not mix with other bubbles
- Equipment will be limited to Bubbles

### Lunch time;

- Will be held outdoors in bubbles weather permitting, if not in designated classrooms.
- Play times will be staggered so not all children are playing at the same time.

## Drop off time;

- Follow one-way system to collect your child
- Adhere to 2m social distancing

Additional cleaning measures;

- Tables wipes after use
- Equipment wiped after use if communal
- Toilets to be cleaned hourly
- Hand washing before and after activities
- Deep clean at the end of every day

First Aid;

- We will be following guidance from HSE and all first aiders will be provided with the advised PPE when administering first aid (see below);
- Face mask
- Gloves
- Apron
- Face shield
